CALL TO ORDER - Mayor Brauninger called the meeting to order at 6:00 p.m.

Mayor Pro Tem Rodriquez made a motion to approve Ordinance 2020-30 for the dis-annexation of approximately 147.33 acres located on the east side of FM 1791, near the intersection of SH 30 and FM 1791, and known as "Parcel 15" in the attached exhibit; the motion was seconded by Councilmember Beebe. The motion was adopted, 8-0.
