- 1. To be granted to take a DSC/MOTC course, I understand that I must:**
 - a. Complete and submit this Request/Affidavit form along with the following items:
 - b. Submit a copy of my valid Texas Drivers License or permit, which is not a Commercial Driver's License;
 - c. Submit proof of valid financial responsibility (auto insurance card) which lists me as a covered driver;
 - d. Pay court costs and fees of _____ \$ 144.00 (non-school zone) _____ \$169.00 (school zone violation) (*call for amount*), in the form of money order or cashier's check - *no personal checks are accepted.*
- 2. For the dismissal of my offense, I understand that no later than the 90th day after the date of this request I must:**
 - a. Present to the court a uniform certificate of completion of a state approved Driving Safety Course ("Court Copy", signed by you) or from a DPS approved motorcycle course.
 - b. Present to the court a Certified Copy (version 3A) of my driving record which I will obtain from the Texas Department of Public Safety either by mail or online at www.dps.texas.gov .
(*Note: The above two items must be turned in together.*)
- 3. I understand that after the 90th day after the date of this request:**
 - a. If I have failed to present to this court proof of completion of the Driving Safety Course ("Court Copy", signed by you), the court will require my appearance at a Show Cause hearing.
 - b. If I fail to appear at the Show Cause hearing, the court will enter a conviction against me for this offense, impose the maximum fine, and issue a warrant for my arrest.

I understand that this request will be denied if I am charged with a violation which occurred in a maintenance or construction zone with workers present or if I hold a commercial driver's license now or held one at the time of the offense.
