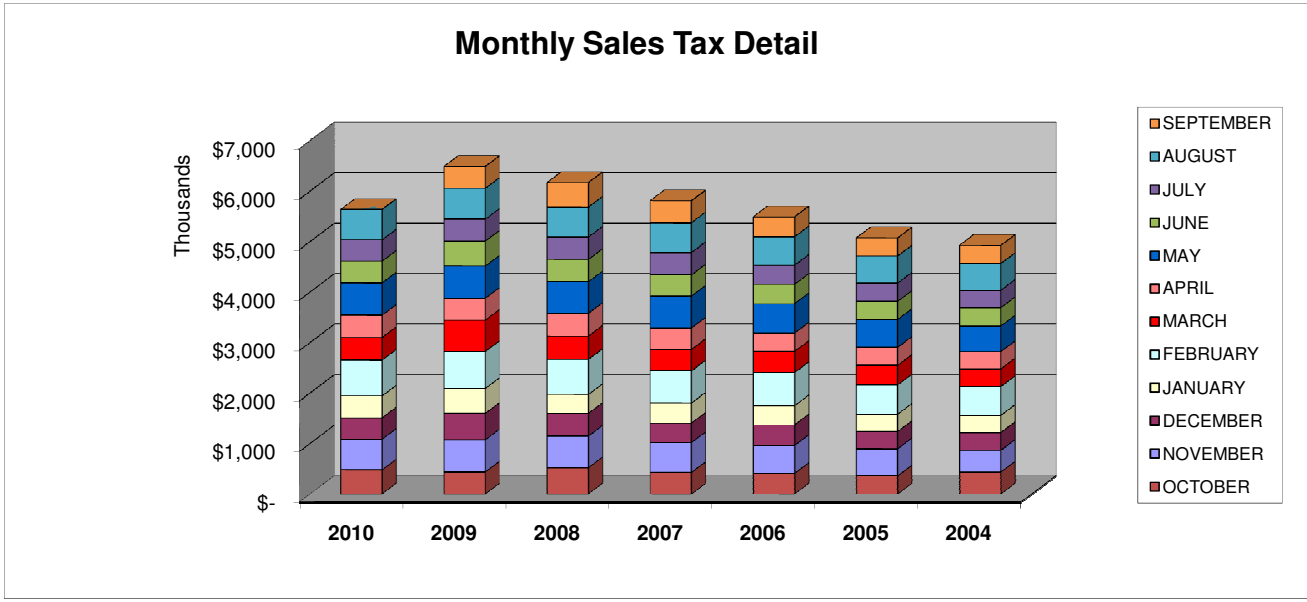
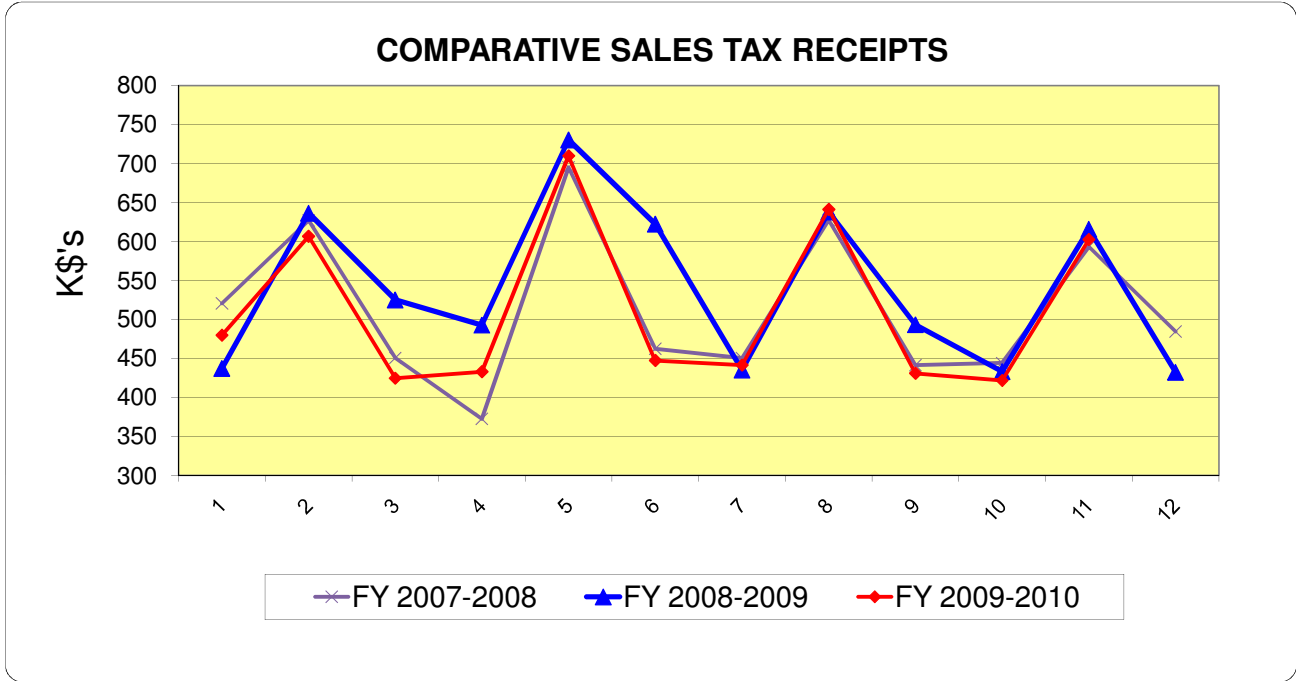

Budget for Sales Tax Revenue for FY09-10 is \$6,610,000. On average for the past 6 years, YTD Sales Tax revenue thru August as a percentage of the total year Sales Tax revenue has been 92.7%. 92.7% of \$6,610,000 budget is \$6,127,470; the actual for YTD thru August of \$5,637,834 compared to \$6,127,470 calculates to an under budget amount of \$489,636 (8%).
